1	<p>As a neighbour and a mother of a child who attends Greenwich Public I wanted to reach out to you about both communication and safety during the construction phase of the hospital.</p> <p>Construction impacts many people who live in the vicinity of sites, that is not something that can be avoided, but it can be managed. What I'm suggesting is that you do a quick letterbox drop and use your web page Planning for the Future – Greenwich development (or better still create a page specifically for the construction period) to communicate things to neighbouring properties as well as provide a contact if there are any concerns. This will potentially reduce the number of calls to Council as well as maintain a positive relationship with your neighbours. I also note that condition A29 refers to documents being made publicly available on your web page but have not been able to find anything that demonstrates compliance.</p> <p>In addition to the above, on my drive to work I noticed a truck parked in the driveway on River Road but it was projecting out past the boundaries of the site and was forcing school children to walk around the front of the truck within close proximity to River Road. I was extremely shocked to see this. There was no traffic control. I appreciate that Hammondcare has engaged a builder to carry out the works, but it is in everyone's best interest that there safety provisions are put in place.</p> <p>You may also want to look at the site fencing which has been placed so it's leaning up against the neighbours wall on St Vincents Road as well as leaning on the mesh fence on St Vincents which looks like it will collapse at any time.</p> <p>I look forward to improved communication and safety.</p>	Yes	9/05/2025	<p>Temp fencing along St Vincents road to be moved clear of the adjoining building. 4	<p>Dear Project Management Team,</p> <p>This is a complaint about the obtrusive light evident overnight during this week, coming from the exterior security lighting operating around your site construction huts precinct.</p> <p>The lighting is very bright and quite invasive. Overnight, it shines into my home, on the east side of Northwood. After dark when I went there to photograph the site contact details, I noticed the lighting would also be extreme for others in the vicinity.</p> <p>Natural environment biota will be negatively impacted, as would star-gazing.</p> <p>Would you please address this issue.</p> <p>Perhaps consider placing the lighting further away from the huts, and shine it in the opposite direction - at your huts and fences instead.</p> <p>thank you for your attention to this matter, Jennifer Schneller</p>	Yes	30/07/2025	Further investigations to confirm exact source of lighting causing the trouble	<p>I've completed a walk-around inspection with Nathan from HammondCare, during which he adjusted two of the carpark floodlights.</p> <p>The most prominent light source visible from Upper Cliff Road was confirmed to be the floodlight mounted to the maintenance building, which Nathan advised was only recently replaced. This supports the likelihood that the neighbour's concerns relate to a more recent change, rather than the lighting associated with our site sheds, which have been in place for some time.</p> <p>I've attached updated photos for reference. Sally / Dave – hopefully this adjustment is enough to alleviate the neighbour's concerns.</p>	31/07/2025
5	<p>Hi Team,</p> <p>I hope you're having a nice afternoon.</p> <p>I'm writing to address the noise from the metal panels on Greenwich Road, which is causing significant disruption to our elderly residents. As an aged care facility, it's crucial that we maintain a peaceful environment, and the loud rattling from passing vehicles is affecting the well-being of our residents.</p> <p>Our maintenance officer has suggested bolting the panels down to reduce the noise. If that's not possible, we'd appreciate any other solutions you can provide to help minimise the disturbance.</p> <p>Thank you for your attention to this matter. 6	<p>To whom it may concern</p> <p>I wish to report my concern at the significant pooling of water along our garage / loft as a result of the hospital (in the process of removing asbestos found on their property) digging a trench along our boundary with no drainage provided.</p> <p>The attached photo demonstrates the significant pooling which has never been there before and certainly not before the trench was dug a matter of weeks ago.</p> <p>My concern is that if this is not fully corrected (correctly drained) current and future pooling will result in the undermining of our garage / loft building, water seepage into the building (especially the loft) and the potential of damp / mildew of the wall in our loft area.</p> <p>Accordingly, I am looking to the hospital to totally rectify this issue (caused by them - digging the trench)) and look forward to advice on your proposed solution and timeframe in completing the task.</p> <p>I have raised this issue with the site manager Jack Isemonger.</p> <p>I look forward to your favourable response in the near future.</p> <p>Kind Regards Stephen Loomes</p>	Yes	22/08/2025	<p>HCA Notes: the depression along the neighbour's property line existed prior to our appointment on site. Two weeks ago, our team cleared foliage and asbestos material in this area as part of the removal works (predominantly a large rubble pile in the middle of the depression) however the depression against the building was already present. The area has historically been lower than the adjoining footpath and effectively landlocked. This was likely exacerbated by the recent heavy rainfall following the removal of ACM material at the upper level. Our overland flow diversion berm is scheduled for installation within the next fortnight; The dilapidation report of the garage, prepared under the SEDA conditions, photos show significant effervescence along the floor and wall of the garage – however this was not noted as a point. This remains evident during my discussion with Stephen last week where we checked there was no surging of the water through his garage.</p> <p>In light of the above, HCA will install an agline against the garage and create falls out to the road with drainage backfill material as discussed with the Neighbour onsite</p>	Drainage and backfilling has been completed	25/09/2025

7	<p>Hi there</p> <p>I am the owner of 47 Gore Street which backs onto the hospital. I just wanted to bring your attention to a water run-off issue. The works were contracted to Wilken, whom have subcontracted the crange component to Borgers.</p> <p>We can confirm the following steps were in place;</p> <ul style="list-style-type: none"> <li>•Both Borgers workers had already completed their pre-induction which includes the below snipped information relating to no use of Vincents. (Current doc Ver R8)</li> <li>•Delivery instruction leaflets have been issued to Wilkens on 13/03 (Ver R2) and 02/09 (Ver R3) both clearly showing no heavy vehicles are permitted from Vincents.</li> <li>•Traffic controllers were onsite and established at substation, however the crane continued past the traffic control and was assumed to be for another project.</li> <li>•Wilken workers were onsite and run through the daily prestart held around 0700 – attached 2 of photos showing note for vehicle entry on gate H2, and no use of St Vincents clearly marked.</li> </ul>	20/01/2026
11	<p>Resident raised concern regarding the upcoming Lane Cove Council footpath upgrade works and the lack of information about alternate pedestrian routes during the works. Resident noted that many Greenwich Public School children use this route to walk to school and raised concern that children may attempt to cross River Road rather than use a longer detour.</p>	Yes		<p>16/04/2026</p> <p>HammondCare/project team to review the resident's concern and clarify the appropriate source of information for alternate pedestrian routes during the Council-managed footpath works.</p>	<p>HammondCare responded on 20/04/2026 advising that the footpath upgrade works are being managed by Lane Cove Council, and that the most accurate information about alternate pedestrian routes should be obtained directly from Council. HammondCare noted that impacts to footpath access are understood to be kept to a minimum and that adequate support should be in place to ensure continued pedestrian use during the construction period.</p>	20/04/2026
12	<p>Resident raised concern regarding Hindmarsh's notification of proposed removal of 8 trees along River Road. Resident queried why trees outside the hospital grounds were being removed, whether Council approval was required, the urgency of the works, and raised concerns regarding loss of outlook/privacy, night works noise, power disruption, local amenity and wildlife impacts. Resident followed up again after the April project update did not address the tree removal concerns.</p>	Yes		<p>27/04/2026</p> <p>Project team to review the resident's concerns, confirm the approval basis for the River Road tree removal works, and provide information to HammondCare to support a response. Copies of the neighbour notification/letterbox-drop were provided by HammondCare project team.</p>	<p>HammondCare responded on 30/04/2026 advising that the tree works form part of the approved Greenwich Hospital redevelopment and are authorised under the SSD consent issued by the NSW Department of Planning. The specified trees are included in the approved Tree Retention and Removal Plan, and the consent allows the works, including approved out-of-hours works, to proceed without separate Council approval. HammondCare also directed the resident to the Greenwich redevelopment website for project documentation and acknowledged the impact of the works on the local area.</p>	30/04/2026

13	Resident raised concern that communications provided to date have lacked sufficient detail regarding construction staging, including the scope, location, timing of works, and potential impacts such as noise, dust, and vibration. They noted that previous advice from Hindmarsh did not, in their view, align with the requirements of the DPHI Out-of-Hours Work approval conditions, and that recent project updates have been too high-level to allow nearby residents to anticipate impacts. The resident has requested more detailed and timely information in future communications, as well as a copy of the dilapidation report prepared for their property. Inconsistencies between the Staging Report and continued hospital function were also raised.	Yes	22/05/2026	Project team to review the resident's concerns, confirm actions conducted to-date and provide information to HammondCare to support a response.	HammondCare responded on 2/06/2026 advising that Stage 1 of the Greenwich redevelopment was completed in January 2026, enabling the commencement of Stage 2 works by Hindmarsh. Essential services have been relocated off-site within the Northern Sydney area to minimise construction risks and disruption to operating hospital functions, while maintaining continuity of care. The project is being delivered in staged works, with a commitment to provide advance notice of potentially disruptive activities such as noise, dust, or vibration, all of which are managed in accordance with approval conditions and mitigation measures. HammondCare also directed the resident to project updates via the newsletter and website and invited further enquiries as needed.	6/02/2026
